## 154TH Participates Applecart "6"

### DISPENSARY APPOINTMENT SYSTEM ESTABLISHED

Effective immediately, all medical treatment at the 154th USAF Dispensary will be by appointment. The only exception to this new policy will be treatment of emergency cases.

If you require medical attention, let your First Sergeant, OIC, or NCOIC know. He will call the dispensary for an appointment for you.

The reasons for the appointment system are to eliminate unnecessary waiting on the part of patients and to provide better medical service with a limited staff. The new system will also insure that your supervisor will know that you are ill and are being treated.

Except for emergency cases, patients without appointments will be sent back to their sections for compliance with the appointment procedures.

### OFFICERS DINING-IN SCHEDULED FOR 9 FEB.

All officers of the 154th are to meet on Saturday, 9 February at a 154th Dining-In to be held at the Kaneohe MCAS Officers Mess. Colonel James Ashford, Commander, will preside. Project officer is Lt. Ed Richardson.

### DRILL DATES

16, 17 February

Hundreds of Oahu households were awakened early yesterday morning as recall procedures of the Hawaii Air National Guard were tested as part of EXERCISE APPECART "6h".

Within the first hour of recall 58% of the 154th's personnel had reported in within the first hour and a half, 79%. After two hours, 90% were accounted for.

Although official results of the statewide exercise are not known at this time, a critique scheduled for 1300 today will go over the 154th's effort. Generally, many improvements over the past exercises were noticed as the various elements of the 154th team carried out their respective missions.

### GROUP TRAINING SECTION REORGANIZED

Consolidation of group training efforts has been recently effected by the reassignment of airmen for various sections to the Group Training Office. Three Air Technicians, headed by T/SGT Kozen Kaneshiro, SSGT. William Lelepali, and A/IC William Fox will staff office.

Under the centralized concept, a more effectively controlled program can be maintained. The new Training Office will actively function to meet training needs of all sections.

AIRMEN SHOULD REPORT CIVIL OFFENSES

A recent National Guard Bulletin points up the need for an airman who is charged or convicted of a civil offense to immediately report this fact to Group Headquarters.

The reason for this is that the Group must act without delay to either discharge the airman or to obtain a waiver for his retention. Any delay may cause a technicality which may prevent his reenlistment.

Any person involved in a violation in which a fine of \$25.00 or more is imposed should report this matter to Headquarters immediately.

Airmen with service obligations are especially cautioned to report civil offenses so that their tenure with the Air Guard will not be jeopardized because of failure to report.
